File format	Manuscript files can be in the following formats: DOC, DOCX. Microsoft Word 2003- 2007 format is preferable.
Length	Manuscripts cannot be more than 5-8 pages.
Layout and spacing	Manuscript should be written in no spacing format. Text should be in one column format not in two column format.
Page and Heading numbers	Inclusion of page numbers is necessary. Main heading should be numbered. Like, 1. INTRODUCTION, 5. CONCLUSION. Subheading should be numbered like, 1.2, 1.3, 5.1 etc. Sub sub heading should be numbered like, 1.2.1, 1.3.4 etc.
Footnotes	Footnotes are not permitted.
Language	Manuscripts must be submitted in English. No other language is permitted.
Abbreviations	Define abbreviations upon first appearance in the text. Do not use non-standard abbreviations unless they appear at least three times in the text. Keep abbreviations to a minimum. If possible, do not use abbreviations in abstract.
Tables & Figures	Table and Figure should be given separate number, such as, Table 1, Table 2 etc. and Figure 1. And Figure 2, etc. Also, a heading is necessary for the figure and table. In the text, Figure should be written as “Figure”. Images in the figure must be clear, use high resolution image.
Reference style & Instructions	For Business Administration Harvard Style must be followed. For engineering subjects, IEEE citation style must be followed. References must be included in the appropriate places of the text in third bracket like [1], [2] etc. References must be written after Acknowledgments (If applicable) or after conclusion with font size 10. Do not use more than 10 references, choose the most important references.
Equations	Write equations in word using Insert equation. Do not provide image. Equation should be numbered as (1), (2) etc.

Manuscript Organization

Manuscripts should be organized as follows. Instructions for each element appear below the list.

Abstract

The Abstract comes after the title page in the manuscript file. The abstract text is also entered in a separate field in the submission system.

The Abstract should:

- Describe the main objective(s) of the study
- Explain how the study was done, including any model organisms used, without methodological detail
- Summarize the most important results and their significance
- Not exceed 300 words

Abstracts should not include:

- Citations
- Abbreviations, if possible

Introduction

The introduction should:

- Provide background that puts the manuscript into context and allows readers outside the field to understand the purpose and significance of the study
- Define the problem addressed and why it is important
- Include a brief review of the key literature
- Note any relevant controversies or disagreements in the field
- Conclude with a brief statement of the overall aim of the work and a comment about whether that aim was achieved

Middle Section & End Section

Middle Section will describe your work. It will vary from work to work. But it is the important part. Some of the elements of middle and end sections general description are given below:

Materials and Methods

The Materials and Methods section should provide enough detail to allow suitably skilled investigators to fully replicate your study. Specific information and/or protocols for new methods should be included in detail. If materials, methods, and protocols are well established, authors may cite articles where those protocols are described in detail, but the submission should include sufficient information to be understood independent of these references.

Results, Discussion, Conclusions

These sections may all be separate, or may be combined to create a mixed Results/Discussion section (commonly labeled “Results and Discussion”) or a mixed Discussion/Conclusions section (commonly labeled “Discussion”). These sections may be further divided into subsections, each with a concise subheading, as appropriate. These sections have no word limit, but the language should be clear and concise.

Together, these sections should describe the results of the experiments, the interpretation of these results, and the conclusions that can be drawn.

Authors should explain how the results relate to the hypothesis presented as the basis of the study and provide a succinct explanation of the implications of the findings, particularly in relation to previous related studies and potential future directions for research.

Acknowledgments

Those who contributed to the work but do not meet our authorship criteria should be listed in the Acknowledgments with a description of the contribution.

Authors are responsible for ensuring that anyone named in the Acknowledgments agrees to be named.

References

For Business Administration Harvard Style must be followed. Any and all available works can be cited in the reference list. IEEE citation must be followed. References must be included in the appropriate places of the text in third bracket like [1], [2] etc. References must be written after Acknowledgments (If applicable) or after conclusion with font size 10. Do not use more than 10 references, choose the most important references.

Rules:

- Do not cite the Unknown and not recognized websites like: Wikipedia, Google etc.
- Total no. of web site citation must be less than paper & book citation.
